You have agreed to purchase and ingest supplemental tablets, pills, powders, capsules, cremes, ointments and drinks sold at this Chiropractic office from various nutraceutical companies including but not limited to Standard Process, Biotics Research Inc., Right Foods, Douglas Labs, Anabolic Labs, Natural Vitality, Shaklee, et al... without Dr. John M Rizzo, DC and/or any of his representatives prescribing them. You are signing this form today to fully disclose to this office the name of the licensed healthcare provider who did in fact prescribe these nutraceutical remedies for purchases made both today and for all future purchases. You agree to only take these products according to the recommended dosages of the prescribing health care provider and/or according to the dosages printed on the labels and abide by the safety warnings the prescribing health care provider recommended as well as those posted on the labels. You also are attesting that you are purchasing these supplements only under direct medical supervision. I am informing you that in taking these over the counter health remedies that even though they are very safe when taken responsibly there can be significant risks- side effects (sometimes fatal-though rare) if they are not taken judiciously and under direct medical supervision with appropriate scientific testing of their need and validity.
